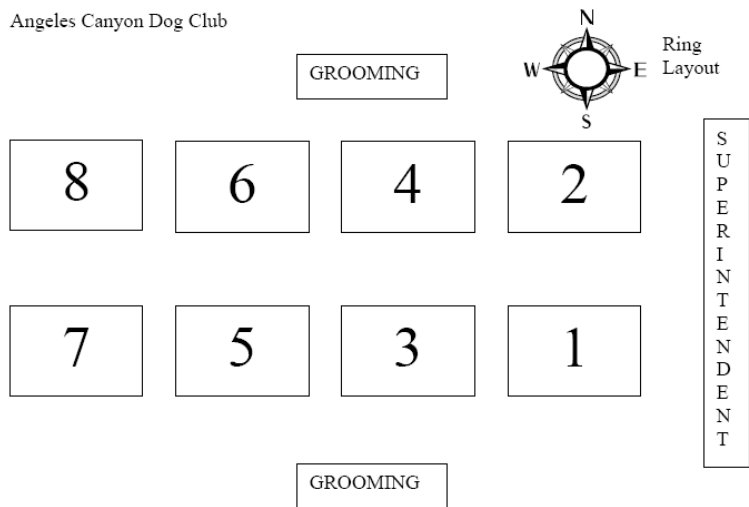

DIRECTIONS TO SHOW SITE

FROM THE LOS ANGELES AREA

I-10 (San Bernardino Fwy – East) Exit Azusa Avenue, turn right and travel south to Temple Avenue. Turn right at Temple Avenue and continue just over a mile. Enter at 16000 Temple Avenue, which is the second gate on left.

60 (Pomona Fwy – East) Exit Azusa Avenue, turn left and travel north to Temple Avenue. Turn left on Temple Avenue. Signal lights and entrance will be on left-hand side.

FROM BURBANK I-5 South to 60 East.

Exit Hacienda Boulevard, turn left and travel north to Temple Avenue. Turn right on Temple Avenue, pass three signal lights and the entrance will be on right-hand side.

FROM POMONA-SAN BERNARDINO

I-10 (San Bernardino Fwy – West) Exit Azusa Avenue, turn left and travel south to Temple Avenue. Turn right on Temple Avenue and continue for just over a mile. Enter at 16000 Temple Avenue, which is the second gate on your left.

60 (Pomona Fwy – West) Exit Azusa Avenue, turn right and travel north to Temple Avenue. Turn left on Temple Avenue and continue for just over a mile. Enter at 16000 Temple Avenue, which is the second gate on your left.

IMPORTANT SHOW GROUNDS INFORMATION

GROOMING

No crates, carts with crates, grooming tables, exercise pens or canopies or umbrellas will be allowed in the aisles. These setups are to be in designated areas only, except as otherwise specifically authorized by the Show Chairs. No grooming or setups will be allowed in the day of show parking lot. Mats must be placed under pens in grooming areas.

GENERATORS: No Generators allowed in arena. AC available under the bleachers and on the outside of the ring area toward the northern side.

No alcohol is allowed on the show grounds.

FAILURE TO COMPLY IMMEDIATELY WITH ANY DIRECTION OF THE SHOW COMMITTEE OR ITS DESIGNEES MAY RESULT IN A BENCH SHOW COMMITTEE HEARING AND REVOCATION OF AN INDIVIDUAL'S RIGHT TO REMAIN ON THE GROUNDS AND REMOVAL OF EQUIPMENT MAY RESULT. SHOW SITES ARE BECOMING MORE DIFFICULT TO OBTAIN AS ARE ACCOMMODATIONS THAT WILL ACCEPT DOGS. THE SCBdFC & ANGELES CANYON DOG CLUB REQUESTS YOUR CO-OPERATION IN CLEANING UP AFTER YOURSELVES AND YOUR DOGS. EXHIBITORS ARE REMINDED THAT THEY ARE RESPONSIBLE FOR CLEANING UP THEIR OWN GROOMING AREA.
